New Court Resource Available in Larimer County

As a local attorney in Larimer County practicing in the areas of estate planning, probate, and elder law, it is not unusual for me to hear people say they do not understand how to perform tasks at the courthouse. If you have ever had to file anything at the courthouse, you probably know that the courthouse staff is not allowed to give legal advice, a fact that is often frustrating to someone who needs limited information about forms. Larimer County will soon have a solution for those frustrations.

In September of 2013 Larimer County officially hired a "Self-Represented Litigant Coordinator" to work at the Larimer County Justice Center. An office has been built on the first floor of the Larimer County Justice Center for the "Self Help Center" where the coordinator will be stationed. The coordinator cannot provide legal advice. However, the coordinator can provide educational materials,

The coordinator will be ready to help the public navigate the progression of legal cases and can help individuals locate the proper forms. In some cases, the coordinator can assist individuals with actually filling information into the proper forms. Currently, several counties in Colorado have Self Help Centers with coordinators who can provide similar information.

The Self Help Center officially opened as a free service to the public on December 4, 2013. Initially, hours will be Mondays and Fridays from 9:00am to 4:00pm and Wednesdays from noon to 4:00pm for walkin appointments. The Self Help Station will be holding appointment only consultations on Thursdays.


